**Business:**

- A. The Borough Council made a motion to approve the Tri-Party Elverson Road Agreement between NMB, Caernarvon Township and PDC Northeast LPIV for Elverson Road. Doreen Smith motioned to approve the agreement, and Chris Weber seconded the motion. The vote was unanimous.
- B. The Borough Council authorize President, Tressie Marroon Bailey to sign the Tri-Party agreement. Chris Weber authorized President Tressie Bailey and Doreen Smith second the approval.
- C. The Borough Council made a motion to approve the modified temporary noise permit submitted by Brinkmann Contractors to start concrete work at 12am for the Panattoni project under the circumstances that Panattoni sends a letter to all surrounding neighboring properties. Doreen Smith motioned to approve the noise permit, and Chris Weber seconded the motion. The vote was unanimous.
- D. The Borough Council made a motion to approve Borough solicitor to draft an ordinance for data center usage in New Morgan Borough. Chris Weber motioned to approve our borough solicitor to create an ordinance, and Doreen Smith seconded the motion. The vote was unanimous.
