## **Correspondence:**

- 1. Informed the Authority that we do not believe there is an active water leak on the Manheim Lot that was mentioned previously at September's meeting. We believe the tank overflowing is what caused it to look like there was an underground leak. Since the Manheim project has been completed and the tank is no longer overflowing; there has not been any sign of leak/water on the lot. The reason the tank was overflowing is because our tank communications is a wireless system and loses communication constantly, especially if it is cloudy/rainy.
- 2. Informed the authority that residence located at 581 Ranck Road, Morgantown Road (owned by Southern Berks Land Company) will be getting connected to the public water system of the Borough
- 3. Informed the authority that we were required to send a notice out to all water customers informing them that we tested high for PFOA's in our water. PFOA is a chemical that can't breakdown naturally. When discussing this with our Authority engineer, the NMUA will be monitoring the results closely and will discuss long-term fixes in the very near future.
