- F. Borough Council will consider approval of the request made by Bill Witman, Engineer for the developer of the Oak Grove Subdivision to re-surface the road its current width for the entire length of the roadway within the Borough. It is to be used for emergency access only. Robeson Township is requesting the Borough’s concurrence. The borough will incur no costs for this project.
